

Student Council Minutes (meeting was on 1/11/06)

Attendance was taken. Emily read thank you notes from Mrs. Johnson for the Sponsor gifts that Dave prepared, from Blessed Sacrament Church for the Council's involvement in the Jubilee Christmas Food Drive, and from Mrs. MacOwan for the flowers that the council sent her after her mother's death. The minutes were read. Jonathan Dunn moved that the minutes be kept as read, Michael Kim seconded, and the motion passed. Mohit gave the Treasurer's Report. Our new balance is \$8,373.92 due to \$304.00 taken in from I.D. sales, and \$839.00 earned from Coke & Pepsi. The Council spent \$200.97 to reimburse Brian's mom for the Hypnotist Convocation, \$288.35 on Coke & Pepsi, and \$207.45 on Materials and Equipment, including \$64.14 for Sponsor gifts. Ryne Kempin and Eliot Mui will sell donuts this Friday (1/13). Brooke Ellis and Laura Kail will sell donuts the following Friday (1/20). Katie Bouman volunteered to post newspaper clippings in front of the high school office before school. She will receive the materials from Dr. Koivo. Ashley announced that there was a communication error in the Mental Health Association Gift Lift this year. Due to miscommunication and lack of gifts to give the Gift Lift, the Council decided to make a donation to the organization. Kyle Mauch moved that the Council allot \$350.00 to the Mental Health Association, Jonathan Liu seconded, and the motion passed. The Council Evaluations Committee was reminded that they needed to evaluate Finals Snacks. The Council decided that extra Finals Snacks would be distributed during Winter Spirit Week (1/30-2/3). Since the Activities Committee still had no final decision on the Club Parking Lot Assignments, Ashley announced that the Executive Board would discuss the issue and give the final decision at the next Council meeting. It was announced that the 2006 Blood Drive is tentatively scheduled for Thursday, May 11. Ashley and Mrs. MacOwan are members of the New Principal Search Committee. The first meeting will be Thursday (1/12) at 6:30 p.m. Any student questions or concerns should be directed towards Ashley or Mrs. MacOwan. Only two Council members, Kyle Mauch and Matt Wan, took the online survey about the new Principal search. Jon Biberstine announced that Council Evaluation Committee members should meet him before school on Thursday (1/12) for Finals Snacks Evaluation forms, and that the forms should be returned to him by Friday (1/13). Kyle Mauch announced that the I.D. Committee would be printing new and replacement student I.D. cards on Friday morning before school (1/13). Judith Asem announced several changes to the Student Council Constitution. These changes included issues such as membership, elections, meetings, attendance, impeachment and censure, clubs and organizations, and school board. Chelsea Pekny moved to accept nine of the fourteen proposed changes to the Constitution, Megan Kochert seconded, and the motion passed. Other changes were not passed because of further changes needing to be made by the Constitutional Revisions committee. See attached sheet for full explanation of proposals and revisions.
